

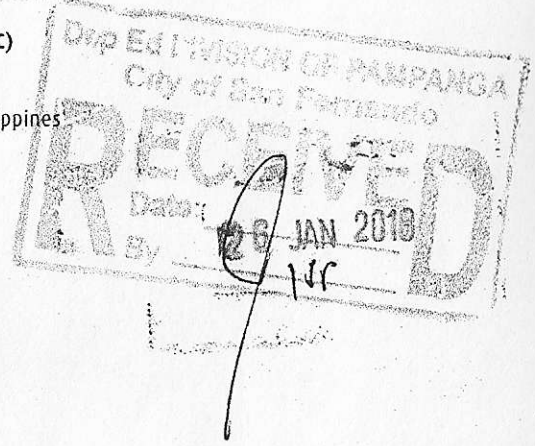

- h. Gr 12 weighted average grade of at least 88% in the second or third grading period


