1. This is to inform the SPED implementing schools of the participation of the Division of Pampanga on the Regional Special Education Program Advocacy entitled "Inclusive Education: Diverse Learners, Learning and Growing Together" on May 24, 2018 at Nueva Ecija Convention Center, Palayan City, Nueva Ecija per Regional Memorandum No. 66, s. 2018 and Regional Advisory No. 178, s. 2018.
2. The original schedule was moved from May 22 to May 24, 2018 because of the conduct of the National Training of Supervisors on the Roll-out of Inclusive Education in Davao City.

Ana ES for the video presentation on SPED accomplishments. All SPED materials and decorations shall be brought to the division office, CID Lower House on May 15-16, 2018. SPED Officers are hereby directed to help facilitate the preparation of the exhibit.
6. There will be a service vehicle for the SPED division representatives. Meeting time at the Division Office is at 3:00 A.M. and departure time is on or before 4:00 A.M. on May 24, 2018 to have ample time in the exhibit's preparation. The division driver, Mr. Nimer Sicangco shall accompany our division representatives the whole duration of the activity.
7. Food shall be free for seven representatives per division. No registration shall be collected from each division but other incidental expenses like travelling allowance from the principal/teachers' stations can be shouldered through the local/school funds subject to usual auditing procedures.
