

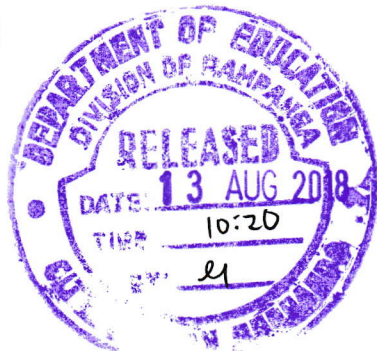

SUBJECT: **SUBMISSION OF LIST OF TEACHERS WHO ARE BEED MAJORS TEACHING IN THE SECONDARY (JUNIOR AND SHS) LEVEL WITH PROFESSIONAL TEACHERS (ELEMENTARY LEVEL) RA NO. 1080 ELIGIBILITY**

- In accordance with **CSC Resolution No. 010005 dated January 13, 2001**, hereto attached, Professional Teachers (Secondary Level) RA No. 1080 Eligibility can be considered appropriate for appointment to teaching positions in both elementary and secondary levels, however, the Professional Teachers (Elementary Level) RA No. 1080 Eligibility is appropriate only for appointment to teaching positions in the elementary level. Pursuant to Republic Act (RA) No. 10533, also known as the Enhanced Basic Education Act of 2013, secondary education consists of junior high school (JHS) education and SHS education. Thus, only Professional Teachers (Secondary Level) RA No. 1080 Eligibility shall be considered appropriate for appointment to teaching positions in the JHS and SHS.
- In view of the foregoing, you are directed to submit a report (hard copy) on the list of teachers who are BEED graduates teaching in the secondary level with Professional Teachers (Elementary Level) RA No. 1080 Eligibility with their original (first) and latest attested appointments / transmittal of appointments (if any) to the HRMO not later than August 15, 2018.
- Those who were affected by the foregoing statements will have the following options:
 - Teachers who do not have yet their CSC attested appointments / newly hired teachers in the Junior/Senior HS will be given items and transferred to the elementary level;
 - BEED teachers with elementary level LET eligibility may take additional units (major) for secondary and take the LET for secondary level.
- All affected teachers with CSC attested appointments are given three (3) years to take the LET examination for secondary if they opt to stay and teach in the secondary level.
- All concerned teachers should be reported, otherwise, it will be the accountability of the school heads of the possible invalidation/recall of the concerned teachers' appointments.
- Immediate dissemination and 100 % compliance of this Memorandum is enjoined.
