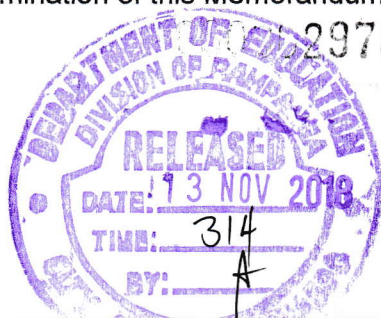

Relative to DepEd Order No. 83, s. 2012 entitled “*Implementing Guidelines on the Revised School-Based Management (SBM) Framework, Assessment Process and Tool (APAT)*,” this office announces the conduct of the Division Validation of School-Based Management (SBM) Level of Practice (Level 2), S.Y. 2017-2018 to all identified public elementary and secondary schools, as recommended by the District and Cluster Coordinating Teams, starting **November 20, 2018**.
