

Experience	3 years of relevant experience (MT-I), 1 year as MT-I or 4 years as Teacher III (MT-II)
Eligibility	RA 1080
Trainings	None requires (MT-I), 4 hours of relevant training (MT-II)

3. Applicants are advised to submit the photocopied documents to the Records Unit and bring their **original of the same** for verification during the scheduled open ranking.

4. Only those who will meet the minimum qualification standards for the said positions will be included in the shortlist of applicants for Open Ranking which shall be posted at the Division Office.
